- c) The Company provided e-voting facility offered by Central Depository Services (India) Limited (CDSL) to its equity shareholders for Remote-E-voting and E-voting at the day of the Annual General Meeting.
- d) The Members holding shares, either in physical or dematerialized form as on the cut-off date i.e. 16th September, 2025 were entitled to vote on the proposed resolutions.

- e) In terms of the aforesaid Notice and as per the provisions of Section 108 of the Companies Act, 2013 read with Companies (Management and Administration) Rules 2014, as amended, the voting period for remote e-voting commenced on 19th September, 2025 at 10.00 A.M. (IST) and ended on 22nd September, 2025 at 5.00 P.M. (IST)
- f) After conclusion of the Annual General Meeting, the votes cast through e-voting were unblocked in the presence of Ms Divya and Ms Anita who acted as witness in accordance with Rule 20 of the Companies (Management and Administration) Rules 2014.
- g) Thereafter, the details containing, inter-alia, list of the Members (Equity Share holders), who voted "For" or "Against" on each of the resolution(s) that were put to vote, were derived from the report generated from e-voting website of CDSL, www.evotingindia.com in respect of e-voting.

The MCA and SEBI vide its respective circulars has allowed companies to convene General Meeting of members through VC / OAVM facility. Voting by means of poll at the AGM by filing of physical ballot papers is therefore dispensed with as no physical AGM is convened. Members who have not voted during the remote e-voting period but attending the AGM, were allowed to cast their vote by e-voting conducted at the AGM. The e-voting process thus includes the consolidated number of e-votes cast during the remote e-voting period and the e-votes cast at the AGM.
