SEBI/HO/CFD/PoD-2/P/CIR/2023/4 dated January 5, 2023, respectively issued by the Securities and Exchange Board of India ("SEBI") (hereinafter collectively referred to as "Circulars") and other applicable laws and regulations, if any (including any statutory modification(s) or re-enactment(s) thereof for the time being in force) that the following items of businesses appended below are proposed to be passed by the Members of Emami Frank Ross Limited (the "Company") through voting by electronic means ("Remote e-voting") & e-voting conducted at the AGM, do hereby submit my report as follows:

- a) The Notice of the One Hundred Sixth Annual General Meeting of Company dated 13<sup>th</sup> August, 2024 along with the Statement under Section 102 of the Act setting out all material facts in respect of Resolutions mentioned therein, were sent to those Members of the Company through email whose email addresses were registered with the Depositories/RTA.
- b) In terms of the abovementioned Circulars the AGM was held through VC/OAVM and hence the physical attendance of the Members and the appointment of proxies by the Members have been dispensed with.
- c) The Company provided e-voting facility offered by Central Depository Services (India) Limited (CDSL) to its equity shareholders for Remote-E-voting and E-voting at the day of the Annual General Meeting.
- d) The Members holding shares, either in physical or dematerialized form as on the cut-off date i.e., 23<sup>rd</sup> September, 2024 were entitled to vote on the proposed resolutions.
- e) In terms of the aforesaid Notice and as per the provisions of Section 108 of the Companies Act, 2013 read with Companies (Management and Administration) Rules 2014, as amended, the voting period for remote e-voting commenced on 26<sup>th</sup> September, 2024 at 10.00 A.M. (IST) and ended on 29<sup>th</sup> September, 2024 at 5.00 P.M. (IST)

f) After conclusion of the 106<sup>th</sup> Annual General Meeting, the votes cast through e-voting were unblocked in the presence of Ms Divya and Ms Sukanya who acted as witness in accordance with Rule 20 of the Companies (Management and Administration) Rules 2014.

g) Thereafter, the details containing *inter alia*, list of the Members (Equity Share holder), who voted "For" or "Against" on each of the resolution(s) that were put to vote, were derived from the report generated from e-voting website of CDSL, [www.evotingindia.com](http://www.evotingindia.com) in respect of e-voting.

The MCA and SEBI vide its respective circulars has allowed companies to convene General Meeting of members through VC / OAVM facility. Voting by means of poll at the AGM by filing of physical ballot papers is therefore dispensed with as no physical AGM is convened. Members who have not voted during the remote e-voting period but attending the AGM, were allowed to cast their vote by e-voting conducted at the AGM. The e-voting process thus includes the consolidated number of e-votes cast during the remote e-voting period and the e-votes cast at the AGM.

The compliance with the provisions of the Companies Act, 2013 and the Rules made there under in relation to Remote e-voting & e-voting conducted at the AGM by the shareholders on the resolutions proposed in the said Notice of the Company is the responsibility of the Management. My responsibility as a Scrutinizer is to ensure that the voting process through electronic voting are conducted in a fair and transparent manner and render Scrutinizer Report of the total votes cast in favour or against, if any, to the Chairman on the resolutions.

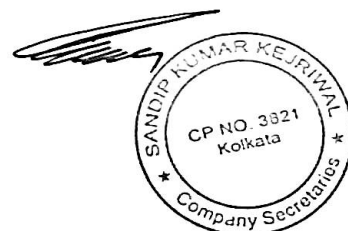
